Puerto Rico launched a lawsuit against nine energy companies on Monday seeking at least \$1 billion in damages, joining other US municipalities in the ongoing legal battle over alleged climate misinformation campaigns. Greece is again extending the naval drills that have largely deterred transfers of Russian oil near its coastline and forced them to other hubs across the world. The Stanlow oil refinery in northern England is getting ready to sell more fuel when a rival plant in Scotland shutters next year. Trading in European diesel futures and options has thrived since Russian barrels were excluded from the continent's benchmark, according to Intercontinental Exchange Inc. Russia's daily crude processing rates so far this month have rebounded to the highest level since mid-January after refineries emerged from seasonal works and emergency repairs following Ukrainian drone strikes.






