



Brent crude is marginally softer this morning but is overall holding onto the gains following a rally earlier this month to recent highs of \$82.40/bbl. Prices have been pushed by market risks from heightened Middle East tensions as concern over a potential attack on Israel by Iran intensifies. Soft China refining data and weaker global demand expectations are offering some downward pressure upside moves.


