

The London afternoon session was very subdued with minimal movement in the front month and likewise with spreads. We initially opened weaker at the low \$100.60 but never rose more than 55 cents closing at \$100.80

Trades of note were contained to Q4 trading in a couple clips of 5kt, as well as some liquidity further out with Q2-26/Q4-26 trading \$2.40 in smalls.
