


The London afternoon session opened at \$99.60. September price saw a small rally to print highs of \$100.45 late in the session, however it then sold off to close at \$99.50.

Trading wise the session was uneventful with a lack of substantial movement in flat price and lack of spreads trading. The notable trade of the session was Q4-25/Q1-26 which traded at \$1.20 in a 15kt clip, Q4 outrights once again had interest and traded in a 12.9kt clip, the session otherwise remained subdued aside from a few front month outrights trading in 10-20kt. Tomorrow marks a national holiday in Singapore so the markets may be quieter than usual, however Chinese CPI and PPI figures will also be released tomorrow morning, which could bring some volatility.
