

London Iron Ore Market Report



The London afternoon session opened today with Sep price at \$93.60, after a sell off for most of the Singapore day, price recovered slightly to print highs of \$95.30 and close at \$95.00.

Oct/Q1 had sustained interest from earlier in the day to trade slightly higher at \$0.40 in 240x80ktm, Nov/Q1 also traded in a sizeable clip of 300x100ktm at \$0.55. Sep/Oct spreads retreated deeper into negative territory, trading pre session at -\$0.20 in 70kt and then a further 150kt in session. Q4 outrights traded a total of 15ktm+, alongside front month outrights trading in a number of 10-30kt clips including some sell side interest on Sep in decent size.
