


## 30 August 2024

The London afternoon continued with some marginal weakness in the flat price, reaching a daily low of \$100.45 after opening 50 cents higher.

The Sep/Oct spread was once again the trade of note, trading at -\$0.15 in a couple of large clips. We also saw a couple of months trade in decent size clips, most notably November at \$101.20 in 80kt.
