


Oil and Energy Market News

Crude is trading around the highest levels of the week after the US Fed cut yesterday added to near term supply issues to set against persistent global oil demand growth concerns. Oil has found some support, with Brent crude futures trading up 1% from yesterday's settlements after the Fed's 50bp rate cut but it remains to be seen if it will lead to any increase in oil demand. Fed Chair Powell cautioned that the FOMC is not on a pre-set course.


