


Despite some volatility in the Singapore day, flat price was fairly stagnant, trading between \$94.90-\$94.20 and closing at \$94.70.

The T+1 session saw a late clear of Q4/Q1, which was a strong pay at \$0.10 in 10kt. We also saw some Sep/Oct trades prior to open. In session, the market was relatively quiet, however Dec/Q2 traded at \$0.70 in 150/50kt.
