The London afternoon saw bid strength pre-open, which accelerated into the session as we rose almost two dollars to a daily high of \$91.45. This strength began to taper off in the second half of the session as we then closed just above \$91.


Some popular trades throughout the day repeated themselves in the session, in particular Cal outrights with Cal25 trading at \$90.75 in a clip of 5kt, providing liquidity further out the curve. Likewise, saw Dec and Jan outrights trading in decent size.


The evening session also saw some quarter spread interest again, but this time Q2/Q4 which traded at \$0.80 in 20kt, keeping spreads narrow after starting wider in the London morning.


