Exxon Mobil Corp.'s top executive vowed to sue more activist investors if they continue to "abuse" the proxy voting process, just months after a lawsuit against Arjuna Capital LLC was dismissed by a federal judge. OPEC kept forecasts for global oil demand broadly steady, even as the cartel and its allies chose to prolong their supply restraints for another two months. Francine strengthened into a hurricane and is expected to make landfall in Louisiana Wednesday after causing some offshore oil platforms to be shuttered, but it will likely miss major natural gas export plants. Russian data show the nation was very close to meeting its OPEC+ crude-output target last month, following a push from the group to improve adherence to its supply deal.


