The Russian government sees its oil and gas revenue falling for the next three years due to lower energy prices and a more lenient tax regime for Gazprom PJSC. Israel launched airstrikes on targets across southern Lebanon, killing nearly 500 people in one of the deadliest days of fighting in nearly two decades and fanning fears of all-out war. The US and Mexico are set to be hit by major hurricanes roaring out of the Atlantic and Pacific oceans within days as the tropics spring to life. Hundreds of ships have been sailing under the flag of Eswatini without the African country's permission to do so, according to a letter from the landlocked nation's government. One of the top investors in US oil and natural gas companies says the nation's shale producers are no longer in a position to aggressively ramp up output and give consumers a break on energy prices.




