Hurricane Helene is pushing past Mexico's Yucatan Peninsula on its way toward Florida, where it is forecast to arrive as a Category 4 storm. BP Plc has experienced delays restarting its Europoort oil refinery in Rotterdam following a power outage earlier this month. Unease in the shale patch is slowing activity as executives surveyed by the Federal Reserve Bank of Dallas lower their view of prices. Guyana's main opposition would ask Exxon Mobil to renegotiate a production-sharing agreement if it wins upcoming elections. Russia has already dispatched a record amount of oil through its section of the Arctic Circle this year, expediting cargo deliveries to China. Trader Nelson Lee, who was involved in carrying out one of the first exports of US crude after finding a loophole in a 40-year ban, is joining a Houston brokerage. South Sudan is pegging its hopes on the resumption of oil production to finance a \$1.6 billion budget for the current fiscal year.






