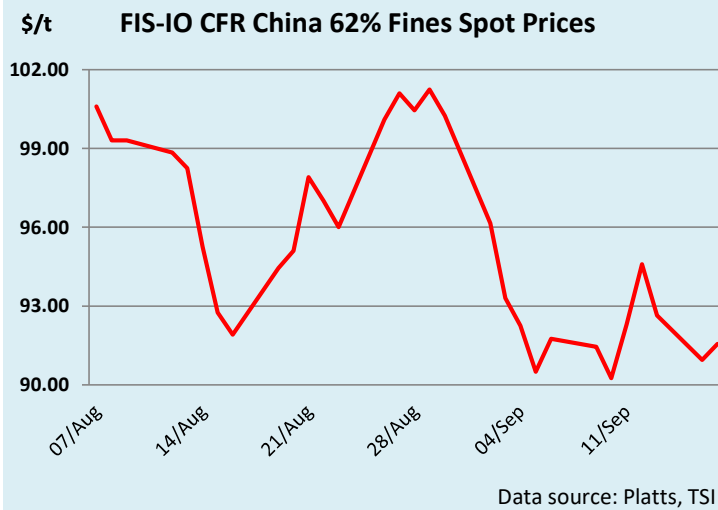

Market Commentary / Recent Trades

As the Chinese holiday continued, the markets remained quiet and range-bound, with prices setting intraday lows at \$91.85 and reaching highs of \$92.60. Trading-wise, the markets also remained subdued, aside from a few notable trades. These included Oct/Q1 trading early in the day at -\$0.30 in 30x10kt and Oct/Dec printing -\$0.25 in 90kt. Most notably, Oct/Nov saw sizeable interest to trade at -\$0.20 in a total of 600kt. In terms of macro events, tomorrow marks the Federal Reserve's (FOMC) much-anticipated interest rate decision.

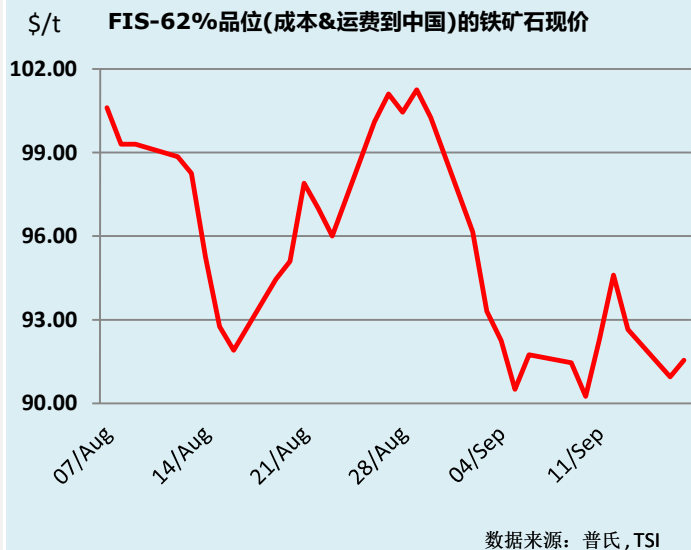

市场评论 / 近期交易

随着中国假期的继续，市场保持相对平静，价格区间波动，价格盘中低点为91.85美元，高点为92.60美元。交易方面，除去几笔合约交易量可观，市场仍然低迷。早盘10月/Q1在负0.30美元交易30x1万吨，10月/12月在负0.25美元9万吨。此外10月/11月有不错的市场兴趣，以负0.20美元的价格交易60万吨。在宏观事件方面，明天备受期待的美联储（FOMC）利率决议即将揭晓。
