



Oil steadies this morning, after another surge yesterday on vague comments by Biden suggesting Israel strikes on Iranian oil facilities are under discussion. Market participants are wait to see if oil supplies will be disrupted, hence the supported prices. Front month Brent however remains below levels seen before September with bearish pressure due to the expected return of Libya oil supplies and ongoing global demand uncertainty.
