
### Oil and Energy Market News


Crude markets are edging higher today, with front month Brent futures having settled last night at \$76.58/bbl. There was a decline yesterday as the Middle East risk premium was moderated, with a firmer US dollar and on comments that there are no changes to the OPEC+ deal under discussion. Brent however rebounded from a low of \$75.15/bbl after a larger than expected US crude inventory build.

Israel's retaliation against Iran is still awaited as the US continues to discourage Israel from targeting oil facilities.


