
## Oil and Energy Market News



Today marked another very volatile day in the fuel markets with massive swings in the front end VLSFO structures. Nov24 Sing 0.5% crack is almost two dollars lower on the day, trading here at the low of \$13.30/bbl. The Rotterdam equivalent is a dollar weaker at \$4.85/bbl.

VLSFO spreads are also a lot weaker, with Nov24/Dec24 Sing down \$3.50 from settlement, although 75 cents up from the low. The Rotterdam equivalent is two dollars off.


