Flat price on the London afternoon initially opened weaker, dropping to a session low of \$104.85. However, this was quickly reversed, before pushing even higher in the last 30 minutes to a high of \$108. We closed at \$107.70.

Outrights early on were rather muted but we did see continued Q1 interest in a total of 30kt.

The more notable trades were on the quarter spreads where once again spreads further out were pushed higher. Q2/Q4 was seen trading \$1.85 across a couple clips totaling 40kt. Prior to this Nov/Q1 was also seen trading \$0.40 in 60/20kt.


