


## 17 October 2024

The London afternoon opened mildly stronger as we reached a session high of \$101.15. However, subsequently the session was muted with the front month trading in and around \$101.00 for the majority of the time. We closed at \$100.65.

Trades in t+1 were in addition, also quiet with the notable exception of Q2 outrights trading in a multiple clips, totaling 50kt.
