




The quiet afternoons in London continued despite some strength in the front month. Soon after open we rose a dollar and challenged the \$101 level before closing at \$100.65.

We saw Nov/Q1 trade before the session at -\$0.35 in 60/20. In session we saw a couple strong pays with Nov/Dec trading -\$0.15 and more importantly the Q1/Q3 traded \$0.85 in 20kt.
