

## **London Iron Ore Market Report**




## 31 October 2024

With a Singapore holiday today, the London afternoon was quiet. Flat price originally opened and was stagnant but came off halfway through down a dollar. Into close we then came off another half a dollar. We closed at \$102.30.

We saw pre-open Dec trading in 50kt, which continued into session in smaller clips. Spreads were muted but Nov/Jan traded \$0.60 in just 20kt early on.
