Oil prices have seen their most volatile start to a month in almost two years as the spiraling tensions between Iran and Israel spur a bumper bout of volatility. Saudi Aramco will provide 42 million to 43 million barrels of contractual crude supply to Chinese customers for November loading, according to people informed by the producer. Global oil and gas prices will moderate in the coming years as the market gets more supply, according to the International Energy Agency. The return of Libyan oil exports is pressuring crude prices from the North Sea to the Mediterranean. Hurricane Milton slammed into Florida's west coast near Tampa with tree-snapping winds and heavy rain, pushing a wall of water onshore and putting lives at risk in the densely populated region. Several major oil producers lost their bid to shed a lawsuit from the California attorney general and local governments alleging they deceived the public about the causes of climate change.






