A preference by Chinese consumers for hybrid passenger cars over pure electric vehicles means the nation's gasoline demand may not have peaked yet, according to Zhejiang Rongsheng Holding Group. Phillips 66 should pay \$604.9 million for stealing trade secrets from a low-carbon fuel provider that it considered acquiring while preparing to enter the California renewables market, a jury said. Phillips 66 plans to halt fuel production at its Los Angeles-area plant in what will be the biggest California refinery shutdown, citing uncertainty about its "long-term sustainability." Iran suffered an oil leak just a few miles from Kharg Island, its top export terminal in the Persian Gulf, according to the semi-official Tasnim news agency, citing a local shipping official.




