Switzerland is investigating companies that use subsidiaries in other countries to sidestep sanctions on Russia, but which are still controlled from Swiss cities such as Geneva or Zug. US crude stockpiles fell last week, bringing total oil and fuel inventory numbers down for fourth weekly decline to the lowest since May. Global oil consumption set to increase to 108.5 million barrels a day by 2035 from 102.7 million currently, analysts led by Natasha Kaneva say in note. Motiva's Port Arthur refinery on the Texas Gulf Coast was forced to shut an FCC and cut rates at other process units Wednesday after losing power at two steam generators, according to a person familiar with operations. The UK said three government bodies are working together to challenge Russian shadow fleet oil tankers if it perceives they have dubious insurance.






