Market Commentary / Recent Trades

Iron ore prices exhibited volatility today despite the ongoing Chinese holiday. We saw intraday highs of \$109.50 early in the morning, followed by a significant pullback to a low of \$108.45. As expected, the day was quieter than usual, with only a few notable trades. These included Nov/Q1 trading at \$0.90 in a total of 180/60kt and Q1/Cal-25 trading at \$1.25 in 10/2.5kt. Additionally, there was strong activity on H1/H2-25 at \$1.75 in 10ktm, and some outright interest in Cal25 at 2.5ktm+.
