
## Oil and Energy Market News


Crude has pulled back this morning, with front month Brent futures sinking by about \$1.50 here, driven by a stronger US dollar in expectation of a Trump victory. Brent reached a high of \$76.24/bbl yesterday but pulled back to a low of \$73.64/bbl earlier today before recovering some ground.

Tropical Storm Rafael is expected to intensify into a category 2 hurricane on a path through the US Gulf of Mexico. Shell and Chevron are evacuating non-essential personnel from its oil and gas assets ahead of its arrival and the Port of Freeport in South Texas closed to inbound vessel traffic.


