


Oil and Energy Market News

VLSFO market structure sunk today, with front cracks off about 35 cents on the day each, at \$11.95/bbl and \$4.60/bbl last done in the Sing and Rotterdam, respectively. Front spreads for both hubs are also off 25-50 cents from yesterday's settlements.

On the other hand, the HSFO complex rallied, boasting stronger cracks and spreads across both hubs further down the curve. The Dec24 HSFO EW is almost two dollars higher on the day.


