


Soon after open the London afternoon saw a sudden rise in flat price, correcting past the start of the asian morning. We reached a high of \$103.40 before closing \$102.55. We saw significant interest on Feb and Jan outrights trading in clips as large as 50kt. Liquidity was also provided further out with with Cal 26 trading in 5kt.


Before open we saw Q2/Q4 trade \$2 in 5kt narrowing spreads. In session we saw Dec/Jan trade \$0.50 in 150kt followed by Q225/Q126 trading \$2.95 in 5kt.
