President-elect Donald Trump's vows to "frack, frack, frack" are about to collide with a global crude glut that's set to, finally, temper record shale production. China imported a record 7.51 million tons of Malaysian crude in October, according to customs figures released on Wednesday. A tanker has hauled gasoline from Nigeria's new Dangote plant to waters off Togo, a sign to traders that the megarefinery's operations could soon potentially shake up regional fuel markets. Shell Plc will exit Ukraine's war-impacted market after selling its stake in a domestic subsidiary to the nation's largest oil producer. The API reported US crude inventories rose 4.8 million barrels last week, according to a document seen by Bloomberg.




