The London afternoon iron ore session opened at \$104.60 and as seen for the majority of the day, price was confined to a very tight range between \$104.50 and \$104.90. Price failed to break free of the range and the session closed at \$104.85.

There was a lack of notable prints in the session, however Dec/Jan did have sustained interest from the Singapore day to trade at \$0.85 in 65kt and we also saw Dec/Apr trading at \$2.15 in 30kt.

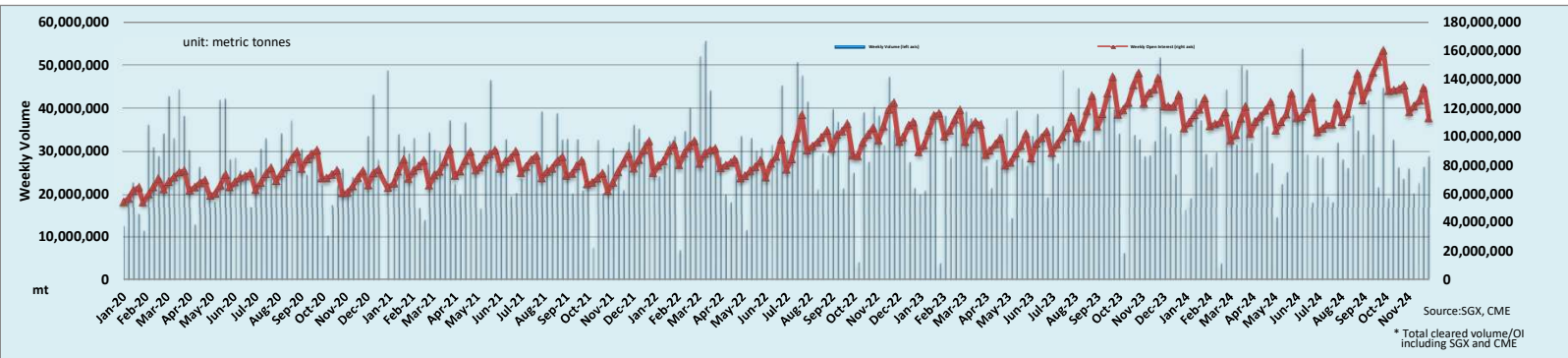
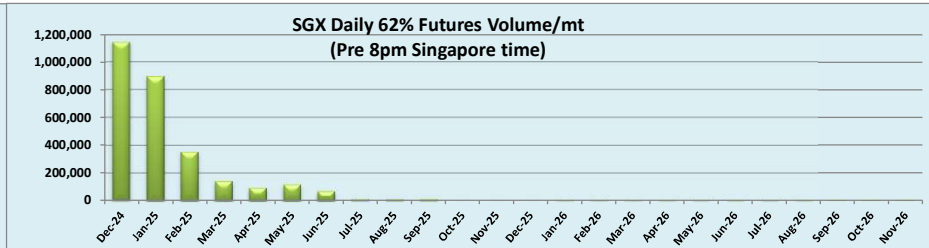
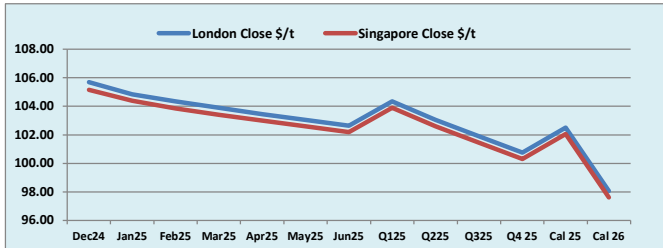
