Sales of gasoline by India's state-owned refiners rose 8.3% y/y in November, while diesel gained 5.9%, according to preliminary data from the companies. About 200 nations couldn't agree on a treaty to curb plastic pollution after two years of divisive negotiations, but said they made some progress and would reconvene the talks next year. President Biden, making the first visit to Africa by a sitting US president in almost a decade, sees the Lobito railway as a way to counter Chinese influence in the region and secure access to minerals critical to weaning the global economy off carbon-based fuels. Oil supplies to German refineries via Poland were unaffected by a leak reported Sunday in one of the two Druzhba pipeline links, Polish state pipeline operator PERN SA said in a website statement. Russia's government will allow producers to export gasoline from the new year, while a ban on other exporters has been extended through Jan. 31.






