Pierre Andurand's riskiest hedge fund surged last month, reviving the fortunes of his investment firm that has swung between big gains and losses this year. OPEC+ is making progress toward an agreement to delay its oil-production revival by another three months, delegates said. Mexico's state-run oil company, facing heightened scrutiny over a string of deadly accidents at its facilities, set an ambitious goal early this year: No more fatalities. Buffalo Bayou Commodities hired Frank Monkam to lead macro trading strategy as the Houston-based firm expands beyond energy. The seaborne flow of oil boomed last month, laying bare the challenges facing nations in the OPEC+ alliance as they try to keep a lid on supply. A tanker hauling Russian crude from the Baltic Sea to India is taking an unusually long route around the UK, just as Britain expands sanctions against Russia's energy industry.
