#### **Market Commentary / Recent Trades**

Iron ore traded in a tight range around \$101 during the Singapore morning session. Short-term spreads saw solid activity, with Jan/Mar trading at \$0.70 and Jan/Feb at \$0.40. As the London session got underway, prices softened, touching daily lows of \$100.50. The narrowing of spreads followed, with Q1/Q3 compressing from \$2.35 to \$2.30. The day reflected a stable start in Asia, giving way to softer momentum in Europe.
