#### **Market Commentary / Recent Trades**

Iron ore saw a modest uptick in the Singapore morning session, pushing up from the open to reach a high of \$102.10. However, activity during the London morning session was largely rangebound, with flat prices holding steady. Post-market close, January iron ore experienced a slight decline, settling just above \$101.

In the Singapore morning, the Jan/Feb spread was actively traded at \$0.45 across multiple clips of 50kt. This was accompanied by notable selling interest in the Dec/Q1 spread, which traded at \$2.70-\$2.85 in volumes exceeding 300/100kt. Other December spreads also attracted attention, with Dec/Jan trading at several levels in smaller clips. The Dec/Feb spread saw activity as well, trading at \$2.75 for 30kt.
