


Further pressure was put on oil prices today, after the headline from Bloomberg: LIBYA PROTESTERS TO ALLOW PORTS TO TEMPORARILY LOAD OIL. It was later confirmed by the country's NOC that the blockade measures by the protesters have been eased, allowing 400,000 barrels per day of exports to resume.

Sing 380 spreads rallied aggressively today, with front end contracts up as much as 2 dollars on the day, trading in decent size considering most of the Asian market is beginning to dwindle ahead of Chinese New Year. Sing 0.5% spreads, on the other hand, were illiquid and traded pretty flat. Feb25 VLSFO cracks for Sing and Rotterdam are flat on the day.

Focus was more on Rotterdam VLSFO spreads today in the absence of the Chinese market, they edged slightly higher.


