The London afternoon was characterised by the slide in flat price as we reached a low of \$103.65 and closing at \$103.80.

The session saw minimal activity besides perpetual Cal26 interest from the Singapore day. The Cal26 traded at \$96 in a total of 10.5kt. Also, Q2 traded at \$102.1 in two clips of 5kt.
