## 23 January 2025

The London afternoon saw volatility in flat price mirroring the Asian morning.

We saw an initial spike to a high of \$104.70(matching the high seen at beginning of day) which was quickly reversed. Then we reached a daily low of \$103.25, closing 30 cents higher. The session was dominated by outrights on the prompt months.
