Canadian crude strengthened from a six-month low after US President Donald Trump's Commerce pick said Mexico and Canada can avoid tariffs by securing their borders. Ukraine claimed it successfully struck a Russian oil refinery and a pumping station on a vital crude pipeline with drones as Kyiv steps up its attacks on its rival's energy infrastructure. Mexico's Dos Bocas refinery is contending with unreliable power supply, a permit filed with the government energy regulator shows, adding to the operational issues that have plagued the project. Mexico's President Claudia Sheinbaum will send a bill to congress outlining how private investors will be required to partner with state-controlled companies in energy ventures, a move aimed at streamlining rules and attracting capital to the industry. Hess Corp. expects net oil production from its stake in Guyana's Stabroek block to drop about 6% in the first quarter as the Payara development undergoes planned maintenance.




