Market Commentary / Recent Trades

The Singapore iron ore market opened at \$96.90, selling off steadily to a morning low of \$95.95. A reversal in the afternoon saw prices regain momentum, returning to the morning open and pushing higher to a session high of \$97.40. By the close, prices eased slightly to settle at \$96.70, marking a choppy but active trading day.

Spreads were notably active, particularly in the morning session. The Jan/Mar trading at \$1.10 for 100kt and later widening to \$1.20 for 200kt. Jan/Feb traded at \$0.85 for 30kt and \$0.90 across 80kt. Further out, Q2/Q4 traded at \$2.15 in 10ktm, while Cal26 saw activity with 7ktm. The afternoon brought renewed interest, with Jan/Feb tightening to \$0.70 for 80kt, and Jan/Apr trading at \$1.50 for 23kt. Feb/May was active, trading at \$1.15 for 72kt, while Feb/Apr saw over 100kt at \$0.70. Further out, Q3'25/Cal26 traded at \$3.75 in 10/2.5ktm.
