### **Market Commentary / Recent Trades**

Iron ore prices remained static today, with the Singapore session opening at \$99.05 and trading within a narrow \$98.50-\$99.20 range. The lack of significant price movement persisted into the afternoon, reflecting muted market sentiment.

In the morning, trading activity included Jan/Feb spreads at \$0.10-\$0.25 over 95kt and Jan/Mar at \$0.55 in 100kt. Feb/Apr traded at \$0.95 in 97.6kt, while the afternoon session saw Feb/Q2 at \$1.45 in 45x15ktm, Feb/Q3 at \$2.80 in 60x20ktm, and Q2/Q4 at \$2.45 in 10ktm. Quarterly outrights were active, with 145ktm in Q1 and 100ktm in Q2.

Despite record iron ore imports climbing 4.9%, concerns over a growing supply-demand imbalance continue to weigh on market sentiment. China's steel sector remains under pressure due to a sluggish property market and constrained infrastructure investment, while incoming low-cost supply, such as Guinea's Simandou project, poses a threat to pricing stability. As the market grapples with these structural headwinds, downside risks to iron ore prices are becoming increasingly apparent.

#### 市场评论 / 近期交易

今日铁矿石市场价格保持稳定,新加坡开盘于99.05美元,价格交易于98.50美元至99.20美元之间。午盘价格保持窄幅震荡,未出现大幅波动。

早盘1月/2月价差多次交易,包括0.10美元交易1万吨、0.15美元交易4万吨、0.20美元交易2万吨和0.25美元交易2.5万吨。1月/3月价差在0.55美元交易共计10万吨,2月/4月价差在0.95美元交易9.76万吨。午盘交易同样清淡,但仍有部分合约交易可观,如2月/Q2价差在1.45美元交易每月4.5×1.5万吨,2月/Q3价差在2.80美元交易每月6×2万吨,以及Q2/Q4价差在2.45美元交易每月1万吨。季度合约交易活跃,Q1交易每月14.5万吨,Q2交易每月10万吨,25年下半年合约交易每月1.5万吨。

尽管铁矿石进口量创纪录增长4.9%,供需失衡的担忧仍拖累市场情绪。中国钢铁行业因疲软的房地产市场和有限的基建投资承压,而包括几内亚西芒杜项目在内的低成本供应的到来,进一步威胁价格稳定。在这些结构性逆风的影响下,铁矿石价格面临的下行风险日益明显。
