



Front month Brent crude futures are peeping back over the \$75.00/bbl mark this morning, up from a low of \$74.11/bbl yesterday as Washington's next steps in its maximum pressure campaign on Iran are weighed with other supply uncertainties. OPEC+ is yet to decide on the planned return of production, Iraq is looking to restart Kurdistan oil exports and Ukraine peace negotiations could ease sanctions on Russia.
