
## Oil and Energy Market News

Crude has fallen quite dramatically today, with front month Brent futures 2.5% weaker into European close. Downward pressure spiralled from weak US consumer confidence data, which has added to fears of an economic slowdown. Meanwhile, the market is weighing US sanctions on Iranian oil companies against the potential for increased Iraq/Turkey pipeline flows and tariff threats.


