

## **London Iron Ore Market Report**




## 05 February 2025

The London afternoon saw flat price relatively muted trading around \$104.00. Towards the end of the session, we saw the high at \$104.45 before closing 20 cents lower.

Mimicking front month movements, trades were also muted. We saw some Feb selling, whilst Q2 traded \$102.70 in 10kt. Spreads were unchanged besides some selling pressure on Feb/Mar which traded \$0.55 in 10kt.
