The London afternoon witnessed a reversal of the majority of the loss seen earlier on in the day. We pushed to a session high of \$106.95 before closing 30 cents lower.

As flat price ticked up, we saw selling interest, most notably on Feb as it traded \$107 in a ticket of 60kt. Spreads mainly saw interest on Feb/Mar trading in a few small clips. Liquidity was seen further out with Cal 26 trading \$97.50 in 2.5ktm.

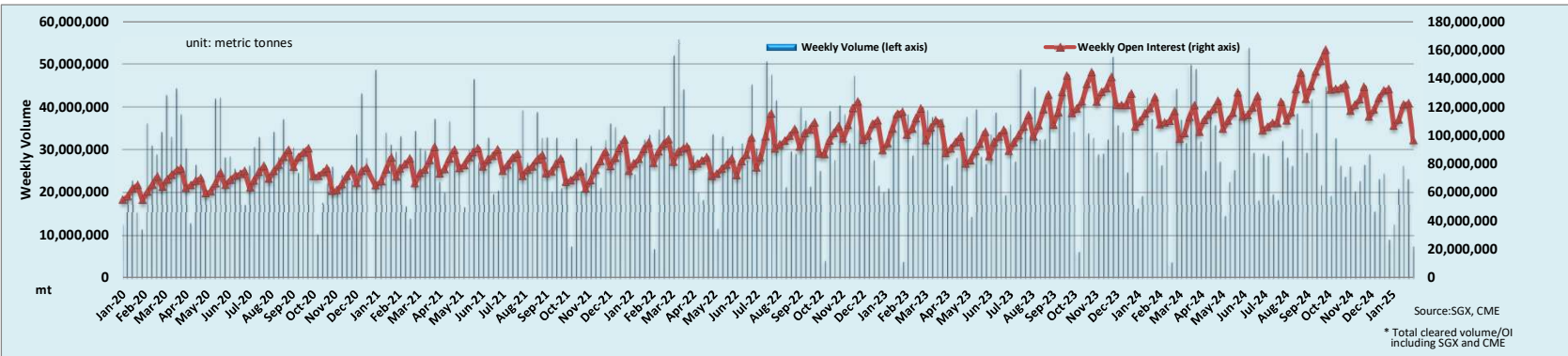
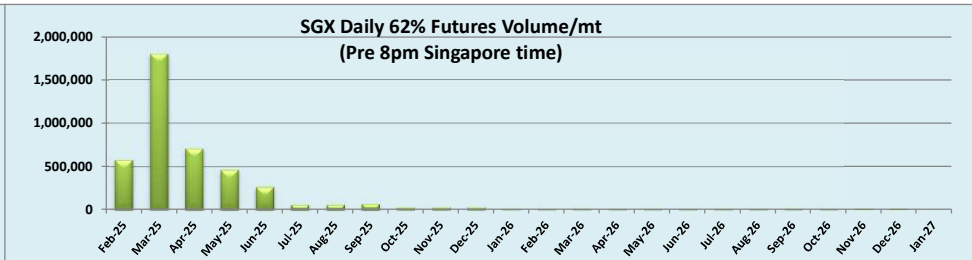
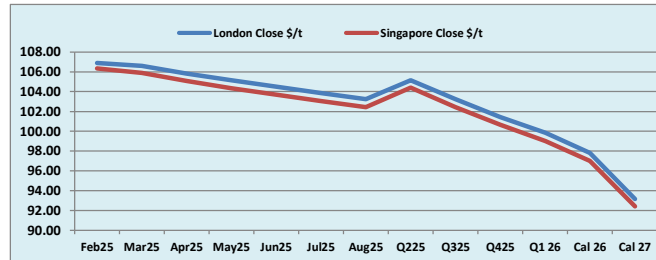
