


The London afternoon session opened at \$106.15 and saw a lack of volatility throughout, price pushed to highs of \$106.65 before pulling back to close at \$106.25

There was also a lack of notable spread action aside from Mar/Apr continuing to trade at \$0.75 in a further 100kt, aside from this the session was comprised of monthly outrights trading in 10-20kt clips.
