## 26 February 2025

The London afternoon opened at \$106.05 and steadily sold off to lows of \$105.20, before recovering towards the end of the session and closing at \$105.65.

Mar/Apr saw sustained interest from the Singapore day and traded at \$0.75 in 150kt and \$0.80 in 85kt, we also saw some Apr outright buy side interest, trading in 100kt and 50kt clips.
