### Market Commentary / Recent Trades

Iron ore futures remained rangebound in the Singapore morning session, opening at \$104.60 and fluctuating within a narrow band between \$104.35 and \$105.10. In the afternoon, bullish momentum emerged, pushing prices to a new intraday high of \$105.95, which also marked the session close.

Quarterly spread interest was active in the morning, with Q2/Q3 trading at \$2.30 in 40ktm and \$2.35 in 20ktm. Q4/Q1 printed at \$1.80 in 5ktm, while Q2 outrights saw trades in 15ktm+. Feb/Mar traded at \$1.10 in 50kt, with additional smaller prints at \$1.30. Two 50kt clips of March outrights also changed hands. In the afternoon, quarterly spreads remained in focus, with Q2/Q3 trading at \$2.40 in 25ktm, Q3/Q4 at \$2.00 in 10ktm, and Q2/Q4 at \$4.40 in 10ktm.
