#### **Market Commentary / Recent Trades**

The Singapore morning session opened today at \$106.65, with prices remaining in a tight range between lows of \$106.80 and highs of \$107.20 throughout the session. In the afternoon, the range-bound price action continued, with prices pushing back up to the \$107.20 area around the session close.

In the morning, we saw some sizable trades directly on Mar/Apr, with \$0.81 printing in 700kt+. Additionally, Q3/Q1 traded at \$3.85 in 15ktm, while Q2/Q3 traded at \$2.35 in 20ktm. In the afternoon, Q3/Q1 traded at \$3.85 in a further 5ktm, while Q2/Q4 printed at \$4.30 in 10ktm and \$4.45 in a 5ktm clip. Aside from these trades, the session remained relatively quiet, with some Apr/May trading at \$0.80 and Feb/Mar at \$0.10, both in small sizes. Additionally, we saw Q2 outrights trading in 50ktm+
