



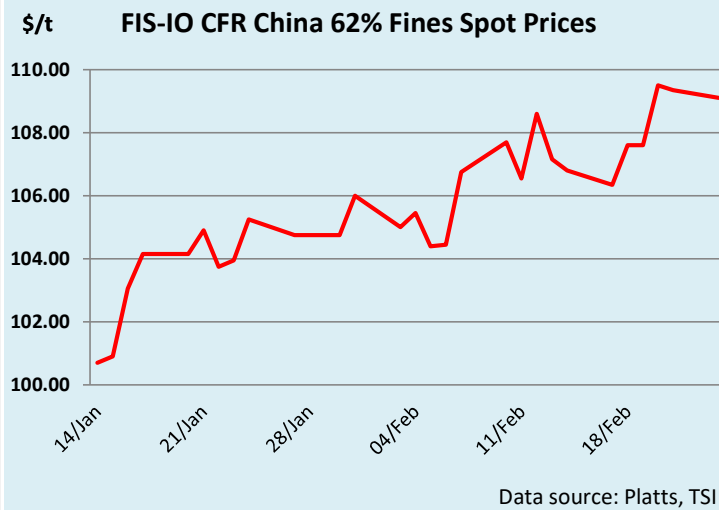

Market Commentary / Recent Trades

The Singapore morning session opened today at \$107.90, with prices remaining within a tight range between the lows of \$107.65 and the highs of \$108.55. In the afternoon, the lack of price volatility persisted, with prices moving sideways, reaching a high of \$108.35. In terms of trading, both sessions were very quiet, with a handful of front-month outrights trading in the 10-30kt range, as well as Cal26 in 2ktm. We also saw some Q2 outright interest in 60ktm+.

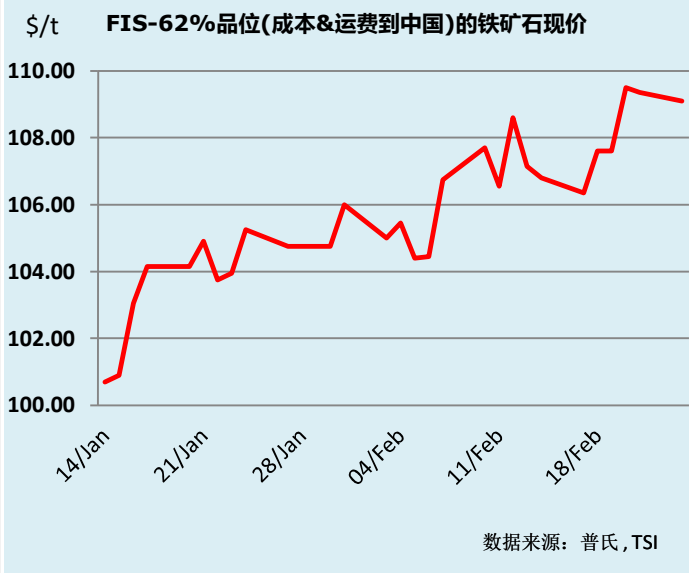
