
### Oil and Energy Market News


Front month May25 Brent crude futures are hovering around Friday's settlement level of \$72.81/bbl. Any support comes from manufacturing data from China and a weaker US dollar amid uncertainty over any progress towards a Ukraine peace deal and potential US tariffs this week.

The 10% tariffs on purchases of energy from Canada and Mexico are due to be imposed on Tuesday. Bloomberg reports that around 80% of the US' oil imports could be at risk from trade and sanctions policies.

## Fuel Oil Market News

VLSFO is falling this morning, with Brent quite flat but front cracks off significantly, especially in the Singapore complex. Front month April25 Sing 0.5% crack has traded an intraday low of \$8.50/bbl – 60 cents off from Friday's settlement. This is now bouncing back up during the Singapore closing window but remains lower on the day.

Sing 0.5% spreads also still feel heavy down the curve, whilst Sing HSFO spreads are stronger in the front.


