



Brent crude futures have been steady today, trading flat to settlement as we head into European close, though Brent is still down from a high of \$74.17/bbl yesterday which was driven by US inventory drawdowns and an expected reduction in supply from tighter restrictions against Iran and Venezuela. Heightened Middle East tensions and recent negotiations for a Ukraine ceasefire have added uncertainties.


